The Agricultural University of Athens (AUA) is the oldest Greek HEI in Agricultural sciences and the 3rd oldest University in Greece. AUA celebrates its 100-years anniversary in 2020. Since then, it has been making valuable contributions to Greek and European agricultural and economic development by conducting basic and applied research in the agricultural sciences and, by producing high quality graduates of all three study cycles as well as cutting edge scientific knowledge.

Among its main goals are to maintain and further improve the quality of mobility and to enhance the international dimension of its activities in order to strengthen its relative position amid the Universities at a local, European and international level.

The strategic targets of AUA to serve institutional internationalization and modernization are:

1. Excellence of Education and teaching through:

- a) continuous intern assessment of all academic members
- b) reformation of study Programmes, introduction of cutting edge courses contributing to labor market needs,
- c) regular seminars and lectures offered by invited speakers from Greece or abroad
- d) Overhaul of practical training goals
- e) Students' dynamic participation in Institutional decision-making and management bodies
- Further development of Career Services Department to improve students' networking and transversal skills
- g) Improvement of student welfare services (library facilities etc.)
- h) Introduction of new teaching methods and establishment of a Scientific Advisory Office

2. Research and Innovation Development through:

- a) Offering of research and academic excellence scholarships to attract students, researchers and teaching staff of high quality,
- b) Seeking out new financial resources to promote research
- c) Financing of projects on time value research topics
- d) Interconnecting research activities with innovation, entrepreneurship and society needs via strategic partnerships with local and international companies
- e) Increasing participation in research projects, facilitated by seminars on project proposals preparation

3. Internationalization through:

Key Action 1

AUA has long term experience in *Key Action 1/ Learning mobility* implementation. It runs successfully mobility of students and staff within EU and third countries from their launch. Apart from that, participation of AUA in KA1 refers to seminars and lectures offered by speakers from abroad, new practical training schemes, chance for students to participate in decision-making management bodies, improvement of students' networking and transversal skills, introduction of new teaching methods, active participation of the academic community in international alliances of high quality, new collaborations with worldwide educational/research institutes, undergraduate courses taught in English to incoming students and so on. AUA participation in KA1 is implemented at Institutional level under the supervision of the Vice Rector of Administration Issues, Academic Issues and Student Welfare and the European Programmes' Office.

Key Action 2

AUA has experience in Key Action 2 projects either as Coordinator or as partner. KA2 projects are implemented by the teaching staff members of AUA and their team group. The extent of participation depends on the teaching staff members' involvement, scientific interest and network. However, the University authorities (Senate and Special Research Funds Account) encourage, facilitate and coordinate participation activity in order to ensure its compliance to the Institutional Strategy.

Indicatively, future participation of AUA in *Partnerships for Cooperation and exchanges of practices* will include reorganization of IT services to facilitate inter-collaboration, reformation

of study programs, improvement of internal evaluation procedures and exchanges of good practices on career matters.

AUA participation in *European Universities* Initiative is already successful. As mentioned above, AUA is partner of EU CONEXUS; one of the 17 European Universities selected during Call 2019. AUA plans to join *Erasmus Mundus Joint Master Degrees* as Partner University in the near future.

Future participation of AUA in *Partnerships for Excellence* action will refer to strategic partnerships with international companies to meet entrepreneurship needs of local society.

Future Participation of AUA in *Partnerships for Innovation Action* will refer to the creation of a Food Innovation Centre and the setting up of spin-off companies.
